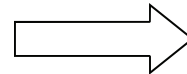
Authorization to Obtain Medical Treatment

I agree to not participate in the use of drugs or alcohol during church activities. I will refrain from the illegal purchase or use of tobacco and alcohol products.

I agree to not use profanity during church activities.

I will not bring or use weapons, fireworks, pornographic materials, or any other inappropriate items.

I agree to refrain from any sexual activity or inappropriate displays of affection during church activities.

I agree to treat all persons regardless of race, religion, and culture with respect and consideration.

I will respect the facilities and homes we are using, and realize that if damage should occur because of my negligence, I am financially responsible. I will not waste time or resources during these activities.

I will portray a positive role model for others by maintaining an attitude of respect, loyalty, patience, integrity, courtesy, tact, and maturity to my peers and adults.
